

# SAFETY SIGNS

The following OSHA safety signs are produced to adhere to Federal specifications in size, color and wording. The signs are manufactured from .040 aluminum. The following are sample legends (custom wording is available).

Caution signs shall be used to warn against potential hazards or to caution against unsafe practices.

### Caution Wording to Insert

- \* NO SMOKING Beyond This Point.
- \* EYE & EAR PROTECTION Required in this Area
- \* HARD HATS REQUIRED IN THIS AREA
- \* DO NOT OPERATE THIS MACHINE WITHOUT SAFETY GUARDS IN PLACE
- \* FLOOR LOAD LIMIT (ANY NUMBER) LBS./SQ.FT.
- \* WATCH OUT FOR FORK LIFT TRUCKS
- \* KEEP AISLES CLEAR
- \* LOW HEAD CLEARANCE
- \* DO NOT WEAR LOOSE CLOTHING WHILE OPERATING THIS MACHINE
- \* KEEP CLEAR - MACHINE STARTS AUTOMATICALLY

Danger signs should be used only where an immediate hazard exists.

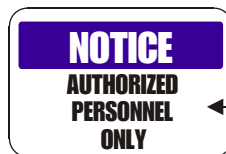

### Danger Wording to Insert

- \* NO SMOKING, MATCHES OR OPEN LIGHTS
- \* DO NOT OPERATE THIS MACHINE UNLESS AUTHORIZED
- \* WATCH YOUR STEP
- \* UNLAWFUL TO OPERATE THIS EQUIPMENT WITHIN 10 FEET OF ANY ELECTRICAL WIRES
- \* EXPLOSIVES
- \* HIGH VOLTAGE
- \* INSUFFICIENT CLEARANCE
- \* KEEP OUT
- \* NO TRESPASSING
- \* RESTRICTED AREA

Notice signs shall be used when there is a need for general instructions relative to safety.

### Notice Wording to Insert

- \* ALL TRAILERS MUST BE CHOCKED
- \* FIRE DOOR DO NOT OBSTRUCT
- \* KEEP THIS DOOR CLOSED
- \* KEEP THIS AISLE CLEAR
- \* NO ADMITTANCE APPLY AT OFFICE
- \* NO ADMITTANCE EMPLOYEES ONLY
- \* SAFETY GLASSES REQUIRED IN THIS AREA
- \* THIS AREA IS PROVIDED FOR YOUR CONVENIENCE
- PLEASE HELP KEEP IT CLEAN BY USING REFUSE CONTAINERS PROVIDED THANK YOU
